# 2022 SSDC PARENT'S COVID-19 SAFETY GUIDEBOOK

Plans, procedures, and protocols to ensure the  
safest possible 2022 summer day camp environment

**As of May 11, 2022**

*We will do our best to provide clear guidance and transparency throughout this process, with the goal of providing and maintaining the safest possible environment for our SSDC community. This document is subject to change as events dictate. As recommendations change, we will continue to make updates. For your consideration:

The American Camp Association (ACA) and Y-USA, enlisted the assistance of Environmental Health & Engineering, Inc. (EH&E) to offer guidance and assist camps regarding current practices and considerations in addressing the novel coronavirus (COVID-19). The objective of the [Field Guide for Camps](#) on Implementation of CDC Guidance (Field Guide) is to provide the best available information, strategies, and concepts regarding the unique challenges that COVID-19 poses to everyone. The Pennsylvania Department of Health and Bucks County Department of Health utilize the guidelines within the ACA's Field Guide and CDC guidelines for summer camps, to govern the operations of youth summer camps during the pandemic. These guidelines set forth protocols governing all aspects of camp operations and describe the steps each camp should take to lower the risk of COVID-19 exposure and spread.

Please note that given the dynamic nature of this pandemic, this guidance may be modified as the situation evolves, and new data becomes available. SSDC will be in regular contact with camp families, staff, and vendors as circumstances require. In addition, SSDC continues to seek guidance from and work with local health organizations (e.g., municipal and state health departments) to engage on health and safety plans and response programs to COVID-19.

## CURRENT CDC/ACA/COUNTY UPDATES-MAY 2022

- We want camp to continue this summer without disruption. At this time this is the most up to date guidance for camps
- The new guidance is based on hospital capacity and the number of new cases (COVID-19 Community Level) There are three levels now: Low, Medium and High
- BUCKS COUNTY IS NOW IN THE **LOW** CATEGORY
- We are strongly encouraging all campers and staff to stay up to date with their vaccinations, get tested if exposed or showing symptoms and wear a mask if you have symptoms, test positive or exposed to COVID.
- At this time anyone who chooses to wear a mask as an additional precaution (at high risk) may continue to do so.

## QUARANTINE VS. ISOLATION

- Quarantine refers to close contact and exposure to COVID
- Isolation refers to being sick or testing positive for COVID
- Those campers or staff who have had close contact or exposure to COVID do not need to Quarantine if they are up to date on the vaccinations or had a Positive PCR Test within 90 days of camp and have no symptoms
- Possible exposure requires campers and staff to wear a mask and test if symptoms appear
- All campers and staff **must isolate** (stay at home) for 5 days from onset of symptoms, testing positive or not up to date on vaccinations. 0 day is when you start symptoms or test positive.
- Additional mask wearing is recommended after exposure, quarantine or isolation.

## LESSONS LEARNED FROM THE 2021 CAMP EXPERIENCE

Those organizations that were successful in operating camps followed these guiding principles:

- Promote healthy hygiene practices.
- Intensify cleaning, disinfection, and ventilation.
- Ensure physical distancing.
- Limit sharing.
- Monitoring camper and staff health and pre-camp screen everyone checking for signs and symptoms.
- Establish smaller group sizes, limit mixing of these groups, and restrict large gatherings.
- **Keep groups and activity cohorts separate by three feet from other groups.**
- Restrict parents, guardians, visitors and non-essential persons from entering camp.
- Educate Staff and campers on all aspects of better health and safety practices

## **SOME EXPECTED BROAD CHANGES FOR THE SUMMER OF 2022**

We know that the situation with Covid-19 may cause changes to all strategies. We expect there to be possible last-minute and/or ongoing changes but we will use this document as a guide. Below are a few of the broad changes that are anticipated.

- We will utilize a cohort model as recommended by ACA. We expect limited enrollment.
  - **Junior and Senior Camp (grades PK- 3) groups will average 14-16 with a minimum of 3 staff.**
  - **Varsity and CIT/LIT groups (grades 4- 8) will average 14-18 with a minimum of 2 staff.**
  - **Campers will remain with their group all day except for club, instructional swim and league activities within their cohort groups.**
  - Morning and afternoon lineups will be held in separate areas, by cohort division.

- Visiting Days, Camp Special Days, CIT/LIT trips, Campwide Shows and Late Nights **will occur as long as Bucks County is in Low/Medium Community Level**
- Absolutely no visitors will be permitted during camp hours.
- Transportation will continue to promote shorter distance and time, utilizing collective stops as needed. Camp will also use a number of 15 passenger Transit Vans.
- Camp will follow the most up to date recommendations from the CDC, PA and Bucks County Departments of Health regarding masking, exposure and isolation related to COVID.

### **ADDITIONAL AREAS OF EMPHASIS DURING PRE-CAMP STAFF TRAINING 2022**

The following topics related to COVID-19 will be included in Staff Training, prior to their first day of camp:

- Staff stay home if sick.
- Health Screening protocols may continue upon arriving to work, for staff and campers
- Cleaning & disinfecting expectations and protocols
- Proper mask protocol(not mandatory in Low Community Level)
- Proper glove protocol
- Social distancing protocol at camp
- Smaller staff to camper ratio; consistent smaller groups
- Facility/Small Group flow of activities
- Modified Sign-In/Sign-out procedures

### **PRE-CAMP SEASON HEALTH SCREENING & WAIVER AGREEMENT**

- All 2022 SSDC attendees may be required to sign a COVID 19 Health Waiver Agreement for 2022
- All 2022 SSDC attendees may be asked to complete a pre-screening document to be handed in the first day of camp (June 20, 2022) The screening will require parents and staff to:
  - Identify if you/your child is at higher risk for complications related to COVID-19 due to medical issues such as diabetes or asthma. Please consult with your child's medical provider to assess their risk and determine if attendance is acceptable.
    - Persons that have a fever of 100.4° or above or other signs of COVID-19 illness will not be admitted to camp. PLEASE KEEP CAMPERS FEELING SICK AT HOME.
      - Campers will be quarantined until picked up.
    - Determining if the camper has been in close contact with a person who has been diagnosed with, tested for, or quarantined as a result of COVID-19.
    - If a camper tests positive for Covid-19 then the family must inform the camp and follow current exposure and isolation guidelines as outlined below.

## NEW HEALTH PROCEDURES TO EXPECT AT SSDC IN 2022

1. POSSIBLE DAILY HEALTH CHECKS
2. HAND WASHING & PROMOTION OF HEALTHY HABITS
3. OPTIONAL FACE MASKS INDOORS DEPENDING ON COMMUNITY LEVEL
4. PHYSICAL DISTANCING
5. INCREASED FREQUENCY OF CLEANING

### 1. DAILY HEALTH CHECKS

- We **MAY** take the temperatures of all staff and campers each day. Any individual exhibiting a temperature above 100.4 will not be allowed to participate in the camp program.
- Staff and campers with one or more COVID symptoms will not be allowed into camp and will be required to get tested, quarantine or isolate if necessary.
- **Staff and parents are required to inform SSDC if someone in their household or a close contact test positive for COVID19**
- **Camp will follow the most up to date guidelines regarding exposure to COVID.** Current guidelines as of **MAY 2022** suggest the following:
  - If you are exposed to COVID and you are up to date on your eligible vaccinations, you do not need to stay home **unless** you develop symptoms. Even if you don't develop symptoms, get tested 5 days (PCR Test) after an exposure (share results with camp). Wear a well-fitted mask for 10 days around others.
  - If you were exposed to COVID and you have a confirmed case from a PCR test, follow the guidelines from above
  - If you were exposed to COVID and you are not up to date on your eligible vaccinations,
  - you must quarantine at home for 5 full days, watch for symptoms, get tested at day 5 (PCR Test) and wear a well-fitted mask for 10 days.
- We may require parents to fill out a simple health checklist form each day **depending on COVID-19 Community Level** confirming their child does not exhibit COVID symptoms before allowing him/her to attend camp.

- We may require staff to fill out a simple health checklist form each day confirming **depending on COVID-19 Community Level** they do not exhibit COVID symptoms before coming to camp.
- *You can* expect the following questions to be asked:
  - Temperature of the individual is taken (must be below 100.4 for access)
  - Have you tested positive for COVID-19 in the past 10 days?
  - Have you come into close contact with a person who tested positive for COVID-19 in the past 10 days?
  - Do you currently feel feverish?
  - Have or recently had any other COVID-19 symptoms such as cough, shortness of breath, sore throat, nausea, vomiting, diarrhea, tiredness, chills, headaches, muscle/body aches, confusion, or loss of taste/smell?
  - Travel restriction- SSDC will follow current County and State restrictions regarding travel.
  - Staff will monitor health by doing visual health checks of children and staff throughout the day.
  - A medical isolation (quarantine) space will be established for any child or staff that is feeling ill and in process to be picked up.
  - Parents will be required to arrange a pick up **within 1 hour** of being contacted if their child is not feeling well.

## **2. HAND WASHING & PROMOTION OF HEALTHY HABITS**

- We will be increasing our hand washing schedule to include 20 second hand washing for all participants and staff before the program, between each activity, before lunch and snacks, after lunch and snacks, and before the program ends, at minimum.
- Staff to train campers on how and when to effectively wash and sanitize hands.
- We will provide signs related to healthy habits throughout camp.
- Under strict staff supervision, increased use of disposable cups at multiple water stations throughout camp day will be scheduled. A dedicated crew will replenish water stations hourly.
- We highly encourage parents to pack a water bottle, clearly labeled with the camper's name, for daily use during camp transportation.
- At the beginning of the camp season, staff members will teach campers:
  - How and when to effectively wash and sanitize hands.
    - Before eating food (e.g., when entering the dining area).
    - Before and after activities.
    - After being in contact with someone who may have been sick.
    - After touching frequently touched surfaces (railings, doorknobs, counters, etc.)
    - After using the restroom.
    - After using common items, such as sports equipment, craft supplies, etc.
    - After coughing, sneezing, or blowing your nose.

- Handwashing Misconceptions - Water temperature is not important. Clean cold and warm water work equally well. Antibacterial soap is not more effective than regular soap. Soap and water are more effective than alcohol-based hand sanitizer if hands are visibly dirty or greasy.
- How to practice social distancing in various settings.
- Coughing/sneezing etiquette.
- How and when to wear face masks (see details below).

### **3. FACE MASKS (Updated for 2022)**

- In general, campers and staff do not need to wear masks when outdoors.
- Campers and Staff **might** choose to wear a mask outdoors if:
  - They or someone they live with has a weakened immune system
  - They are not up to date on COVID vaccines or live with someone who is not up to date.
- Campers and Staff who are **not up to date** with COVID vaccines may wear a mask indoors depending on COVID-19 Community Levels.
- Campers and Staff who are **up to date** with COVID vaccines may choose to wear a mask indoors to maximize their protection.
- Staff and campers should bring appropriate, N95 or KN95 face masks for their own personal use.
  - Campers may bring one face mask, have a second one in a sealed plastic bag in their daily camp bag and one in their “Stay-In-Camp” bag, in case the first becomes wet or otherwise dirty during the day.
  - Face masks should be identified by the camper’s name (or initials) along with the bunk number on the outside of the mask. (We recommend clothing labels like [OliversLabels.com](https://www.oliverslabels.com)) ●
  - Face masks should not be shared with anyone else.

### **4. PHYSICAL DISTANCING & CO-HORT PRACTICES**

- Social distancing will be practiced at all times.
  - In any inside space, including the dining room (set up space for social distancing) ○ Outdoor (State and local regulations state that camps should operate outdoors as much as possible)
  - Transitions (walking to the bathroom or a new activity area)
  - During certain camp activities
- Groups will be limited to an average of 12-18 campers, depending on age.

- Groups, other than cohorts, will not interact with each other throughout the day.
- We may hold full camp-wide activities depending on current guidelines. If we cannot hold a full-camp activity then each camp (Junior, Senior, and Varsity) will have their own special events.
- Staff will be assigned to specific groups and will not interact with other groups or staff as far as practicable. In all cases, masks will be worn and social distancing strongly encouraged for outdoor activities and may be required for any indoor activity.
- All activities will be adjusted for safe interactions following social distancing rules.
- We have adjusted our program activities to adhere to state and local guidelines, but we remain prepared to adjust again as situations change.

### **5. INCREASED FREQUENCY OF CLEANING**

- Communal spaces will be cleaned and disinfected at a minimum of once per day.
- Highly- touched surfaces will be cleaned and disinfected multiple times per day.
- Shared items will be cleaned and disinfected between uses.
- Disinfectant sprayers will be used to clean outdoor structures made of plastic or metal daily. ●
- Outdoor wooden surfaces, such as play structures or tables, will be cleaned according to standard camp practices and more frequently if needed to remove obvious soiling. ●
- Changing areas and locker rooms will be cleaned and disinfected daily.

### **ADDITIONAL PROCEDURES TO EXPECT AT SSDC IN 2022**

#### **TRANSPORTATION (Updated for 2022)**

The safety of our campers and staff is our highest priority. Continuing this summer camp staff will only be driving themselves and their own family members. This summer SSDC will utilize school buses and 15-passenger vans. Buses will operate at approximately 50% of capacity to promote social distancing. While our preferred policy is to pick campers up at their driveway, due to these factors, and to promote shorter travel times for campers on vehicles, several changes that affect your daily transportation routine may be required depending upon where you reside. Some collective bus stops within a short distance of a camper's home may be required.

## BUS PROCEDURES

- Parents should conduct daily temperature and symptom check before putting campers on the bus. Any parents or siblings with temperature or other COVID related symptoms should not approach the bus stop area.
- Be ready for pickup at the designated time and/or designated bus pick-up stop if requested.
- **Campers and staff MAY BE required to wear a mask while on the bus.**
- Maintain physical distance with other parents/guardians and campers.
- Parents are not permitted to board the bus.
- Campers and staff shall sanitize their hands when boarding the bus in both the AM and PM. Camp staff will check temperatures upon boarding the vehicle or upon arrival at SSDC. Campers must sit in the same assigned seats daily facing the front always. SSDC staff will keep a seating chart for reference.
- One camper per bench seat. Siblings may be required to share a bench seat.
- An individual camper may also share a bench seat with a “Bus Buddy”. A Bus Buddy may be from outside your household, but they must be someone that your child quarantined with and/or are in the same cohort group at camp. **A Bus Buddy must be requested in advance and approved by both families, as well as SSDC, in writing.**
- Buses will have approved “star seats” for appropriate age campers.
- Eating on the bus is not permitted. Please pack a water bottle for daily use during camp transportation with the camper’s name on it.
- Vehicles will be cleaned and disinfected daily. High touch services will be disinfected after each trip.
- Bus windows will be opened several inches (if can be done so safely) during all periods of vehicle occupancy to circulate fresh air. With windows open 1” to 2”, the air on the bus is circulated approximately every two minutes.

## PARENT SELF-TRANSPORTATION OPTION

The Parent Self-Transportation Option to drop-off/pick-up your child at camp is available. If you choose this option, you will be entitled to a transportation rebate of \$200 per camper for full season campers, \$150 for Any 6-Weeks and \$100 for 4-week campers. You will receive detailed instructions prior to the first day of camp regarding procedures. Below is a summary of those procedures:

### Arrival in AM for SELF-TRANS campers

- Arrive between 8:30 & 8:50 AM for drop off.
- Please display a SELF-TRANS placard provided to you on the back of your visor or dashboard so that it may be seen by SSDC staff.

- Follow signs and staff instructions to the designated drop-off area. Do not get out of your car, SSDC will assist your child. Say goodbye to your child inside the vehicle.
- SSDC staff will assist campers in getting to area lineups and meeting their counselors.
- SSDC staff will perform initial health screening of campers upon arrival and have them sanitize their hands.
- If you need to speak to someone, please call the office after leaving our parking lot in the morning.

### **Dismissal in the PM for SELF-TRANS campers**

- Arrive between 4:00 & 4:20 PM after all other vehicles have left camp.
- Please display a SELF-TRANS placard provided to you on the back of your visor or dashboard so that it may be seen by SSDC staff.
- Follow directions as given by SSDC staff to pick up your child.
- Please be courteous and patient as we dismiss your child to you.
- Campers will be brought to you by SSDC staff.
- Do not leave your vehicle. If you need to get out of your vehicle for any reason, please maintain physical distance with other parents/guardians and campers and wear a mask.
- Please be prepared to show identification until the staff gets to know you.
- If someone else is picking up your child, please make sure that you call the office to let us know. We will not release your child to someone other than a parent or guardian.
- For everyone's safety please drive slowly and carefully when entering and exiting the parking lot. Please maintain the required 5 mph speed limit while inside our camp property.

### **EXTENDED HOURS**

We will be offering extended hours from 7:00am to 6:00pm for 2022. **Limited spots will be available.** No occasional "drop in" spots will be offered. Policies and procedures regarding Early Care and / or Late Care at SSDC will be provided upon request as further development occurs.

### **EARLY PICK-UP/LATE ARRIVAL PROCEDURES**

The Sign-In/Sign-Out Process for will be detailed below.

- All parents are strongly recommended to wear masks while at camp.
- We strongly encourage the same parent/guardian to sign-in and sign-out.
- Each pen is used by one person only. Dirty pens will be disinfected on a regular basis.
- Hand sanitizer will be available.

### **EARLY PICK-UP (WILL CONTINUE FOR 2022)**

For those families that may require an early pick-up, please follow the following procedures:

- Send a note with your child to camp or call at least 30 minutes in advance of your arrival and your child will be waiting on the front porch of the office.
- Please park in the front parking lot after checking in with the security guard.
- Please be prepared to show identification to SSDC staff.
- The office will be made aware of your arrival.
- **Remain in your vehicle with your mask on and an SSDC office staff member will escort your child to your vehicle.**
- Do not leave your vehicle. If you need to get out of your vehicle for any reason, please maintain physical distance with other parents/guardians and campers and wear a mask.
- If someone else is picking up your child, please make sure that you call the office to let us know. We will not release your child to someone other than a parent or designated guardian.

### **LATE ARRIVAL (WILL CONTINUE FOR 2022)**

For those families that may drop off after camp has started, please adhere to the following procedures:

- **Please park in the front parking lot after checking in with the security guard and remain in your vehicle.**
- The office will be notified of your arrival.
- An SSDC staff member will approach to help sign-in your child.
- Masks must be worn. Please maintain physical distance with other persons who may be in the area.
- SSDC staff will perform the initial health screening of a camper upon arrival.
- After screening, campers will be escorted directly to their individual group by SSDC staff.

### **CAMP PROGRAM & ACTIVITIES**

Camp may continue to look a little different than in previous years, but we will still have so many of the activities that campers love (Hammy's Kitchen, Arcade, Old School Gaming and Horseback Riding), as well as some new surprises! Facility upgrades include additional outdoor tents, increased ventilation and air filtering of indoor spaces, outdoor hand washing stations, and additional hand sanitizing stations throughout the camp grounds.

- In buildings with windows, if the outside air temperature and humidity are moderate, all windows will be opened, ceiling fans and/or floor fans will be on to promote air circulation.
- Additional ventilation fans will be installed as required in indoor spaces.
- Campers and staff may wear face masks during indoor activities as guidelines dictate and when maintaining physical distancing is not feasible.
- In general, we will continue to hold activities outdoors as much as possible.
- Indoor spaces that have HVAC systems will utilize high efficiency particulate air (HEPA) filter air cleaners with a MERV-13 filtration rating.
- If the use of MERV-13 or greater filtration is not possible, portable HEPA units and/ or air scrubbers will be used in high-traffic areas to provide continuous recirculation.
- If windows must remain shut due to weather or safety conditions, we will maintain continuous operation of exhaust fans.

## RAINY DAYS

SSDC has an amazing amount of indoor space, large tented areas, and covered pavilions. This permits us to have an entirely planned out rainy day schedule when an occasional rainstorm passes by for part or all of the day. For 2022 utilizing this indoor capacity for an entire rainy day while trying to social distance may be challenging, but we are determined to safely succeed. If *extremely severe* weather is forecasted and, for the safety of our campers and staff, it appears necessary to close camp for the coming day, we will notify all camp families and staff by 10:00 PM the night prior.

## CIT/LIT PROGRAM AND FIELD TRIPS (Updated for May 2022)

As of this moment we are scheduling out of camp trips for 2022. Of course, like all of this, if things change, we will inform everyone in real time.

- The Counselor-In-Training [CIT-current 7th grader] and Leader-In-Training [LIT-current 8th grader] Programs will continue to allow older campers to help with younger campers if they choose.
- CITs & LITs will participate in a portion of each day with a younger bunk under the supervision of a Senior Counselor. CITs/LITs will participate in a portion of each day in recreational activities supervised by a Leadership Counselor.
- LITs who wish to be considered for JC positions in 2023 must be able to meet certain criteria as outlined in SSDC's Leadership Program.
- CIT/LIT trips may occur this summer for those that wish to go.

## **SWIMMING**

COVID-19, according to the CDC, is not waterborne. There is no current evidence that COVID-19 can be spread to people through the water in a pool.

The swim program shall:

- Ensure campers and staff practice proper hand hygiene prior to entering and leaving the facilities or waterfront.
- Space groups of campers 6 feet apart while waiting to enter the pool. Campers will have designated entrance and exit procedures to adhere to.
- The pools will be divided by ropes into different swimming areas.
- Participate in instructional and free swim with only their group in a designated section of the pool.
- Maintain the same instructors with each group of campers each day.
- Campers finishing PK through 4th grade will have instructional swim every day. Campers in our 5th and 6th grade will have free swim activity options.
- All campers will have one free swim period each day.
- Frequently touched surfaces such as lifeguard stands, railings, etc. will be cleaned and disinfected daily.
- Shared items and equipment such as kickboards, life-saving devices, pool noodles, etc., will be cleaned and disinfected daily.
- If two groups are sharing a bunk changing space face masks will be required when both groups are in the room at the same time.

## **FOOD SERVICE**

We continue to offer food service for our campers. Some adjustments to the number of lunch items offered and seating arrangements in the Dining Hall are anticipated. The large Yellow Tent may be used on a rotating basis for lunch to promote social distancing.

- Campers and staff wash their hands with soap and water prior to eating. Additional hand sanitizing stations at the entrance of the dining facility are also available.
- Decrease the number of campers in the Dining Hall to allow campers to maintain physical distance.
- Tables shall be assigned for each group for the summer.

- All camps will eat either in the Dining Room, based upon availability, or under a tent and be physically distanced.
- CITs/LITs will always eat with their bunks or cohort group at the designated lunch period.
- Specialists, by area, will eat at a designated spot inside the dining hall or outside based upon availability with their camp cohort staff group.
- Clean and disinfect the dining room and outdoor tables between meals.
- Salad bars, self-service, and other configurations that require campers to use shared utensils may not be permitted for 2022.
- Prioritized use of “grab-n-go” food items (bagels, sandwiches, fruit, salads, condiments) which will be retrieved by staff on behalf of campers.
- Camp will utilize a family style service for all bunks (main meal and drinks)
- During family style service, staff, with clean/sanitized hands, serve everyone from the table’s serving dishes.

#### **MEDICAL STAFF AND NURSES OFFICE**

SSDC has two highly qualified, and child health experienced, Registered Nurses on site every day.

- All campers who visit the Nurses’ Office for any reason, will wait outside in designated spots.
- An assessment of symptoms and health screening, including temperature check, will be conducted.
- Based upon their medical needs, they will be permitted to either go into the Nurses’ office or sent to a designated quarantine area.
- Inhaler treatments will occur outside.
- All campers who receive medication daily will report directly to the designated Med Station near the Nurses’ Office.

#### **IN THE EVENT OF A SUSPECTED CASE OF COVID 19, SSDC WILL:**

- Interview the confirmed or suspected case and begin contact tracing in coordination with appropriate local and state health resources, as warranted.
- Conduct temperature and symptoms check of the individual according to camp processes.
- If camper or staff is suspected to have COVID-19 based on this assessment, we will:
  - a) Ensure individual is wearing a face mask
  - b) Isolate individual(s) by separating symptomatic individuals by at least 6 feet.
  - c) The isolation area will be at least 6 feet away from other areas of the health center.
  - d) Appropriate transportation will be arranged ASAP.
- Notify camp management, parents/guardians, and appropriate healthcare providers in accordance with guidance from local health officials.

- Advise those who have had close contact with a COVID exposure to follow current CDC guidance as outlined in the beginning of this document under Daily Health Checks
- Confidentiality, as much as possible is the camp setting, will be maintained. The name or any potentially identifying information of the confirmed or suspected case will only be shared with the campers' parent/guardian and health authorities as required.

### **IN THE EVENT OF CONFIRMED COVID 19 EXPOSURES, SSDC WILL:**

- Immediately inform parents/legal guardians about any potential contact their children may have had with suspected or confirmed cases.
- Immediately inform parents/legal guardians if their child is experiencing any symptoms.
- Immediately carry out "contact tracing" to determine the potential or confirmed case's contacts with other campers or staff members over the previous two or more days. CDC defines close contact as interactions within 6 feet for more than 15 minutes. (Contact tracing will be carried out by trained staff in conjunction with the local health department.)
- For campers and staff within the "group" of the index case, surveillance for symptoms will be enhanced and we will minimize this group's exposures to other "groups." This could include separate programming and dining times.
- We may consider asking an exposed "group" to remain home until confirmation of diagnosis can be made, and if positive, remain home until the "group" is determined cleared of infectious risk or transmission as required by current CDC Guidelines.

### **IN SUMMARY**
